Commitment to achieving Net Zero

Birketts LLP is committed to achieving Net Zero emissions by 2035.

Birketts LLP is developing its environment, social and governance strategy to work alongside its environmental management system.

To continue our progress to achieving Net Zero, we have a carbon reduction target to decrease carbon emissions to 300 tCO2e by 2027; this is a reduction of 25%.

Baseline Emissions Footprint

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions can be measured.

Birketts LLP started collecting emissions data in accordance with Streamlined Energy and Carbon Reporting (SECR) requirement for our financial year ending May 2020.

Initially Scope 3 emissions were not reported for the year 2019/20 and were calculated retrospectively in the following reporting year.

Completed Carbon Reduction Initiatives:

To address emissions and to assist with the reduction of our carbon footprint, we have undertaken the following in the business year 2022/23, and continue to promote these initiatives:

- Promoting energy efficiency in all offices through induction and continued awareness training
- Minimising waste and adopting sensible and sustainable recycling policies in respect of our paper and food consumption, including a less paper office and reduced printing strategy
- Actively reducing energy consumption by the efficient use of building management systems and control of HVAC systems in all office

- Recycling all printer cartridges, toners, paper, and plastics through, where possible, an ISO 14001 certified and accredited provider
- Providing safe and comfortable working conditions
- Encouraging colleagues to car share, travel as a group, or walk or cycle to work and supporting local businesses to reduce transport and carriage use.
- Promotion of the Green Car Scheme
- Active member of the Legal Sustainability Alliance
- Sustainable office refurbishment and adoption of LED lighting
- Reduction of waste to landfill through recycling schemes and in-house training on the same
