Riparian rights for residential developers

When acting for residential developers on land acquisition, it is important to establish that there are sufficient legal rights for the passage of services to and from the proposed site. Surface water rights in particular, have not proved easy, especially where surface water drains to a nearby river or other natural watercourse.



New legislation to standardise consumer code for housebuilders

On 22 October 2024 the Government published their response to the Competition and Market Authority Housebuilding Market Study report. This will result in secondary legislation to ensure that all housebuilders are using a single mandatory consumer code to provide parity for all new homebuyers.








The new NPPF – what does it say, and what does that mean?

The Government has published the NPPF and it takes effect for all development management decisions from 12 December 2024, whereas for the purposes of plan-making this version of the Framework will generally take effect from 12 March 2025.









CSR day at Purfleet Heritage and Military Centre

Hear from Chris Hoxley, who shares anecdotes about his time working in the residential development sector.




